Position description

The Department of Medicine of McGill University invites applications for a full-time position as a member of the Contract Academic Staff as a clinician-teacher at the rank of Assistant Professor. This ranked position within the Contract Academic Staff does not confer eligibility for tenure.

The Department of Medicine is a leader in academic medicine, our educational and research missions support excellent and innovative clinical programs across our teaching hospitals. Lachine General Hospital is one of McGill's University Health Centre's (MUHC) teaching hospitals affiliated with the Faculty of Medicine at Canada's internationally renowned McGill University, located in the vibrant and multicultural city of Montreal, in the province of Quebec.

Job Duties

The candidate is expected to provide the following Gastroenterology clinical services: Endoscopy Clinic, Consult Service, General Outpatient Clinic and cover evening and weekend on-call duties.

The incumbent is expected to assist the academic program in clinical innovation in the Division of Gastroenterology and Hepatology.

The candidate is also expected to be actively involved in all aspects of McGill's academic mission (teaching and supervision of clinical trainees, and involvement in academic and administrative committees) and will be expected to demonstrate a commitment to equity, diversity and inclusion in these activities.

Qualifications and Education requirements

Candidates must hold an MD degree and must have completed specialty training in Gastroenterology, be Royal College certified (or equivalent) and be eligible for licensure in Quebec and certified by the Collège des médecins du Québec. At least one additional year of clinical and /or research training is required.

Applicants should also have experience in conducting clinical studies and have strong leadership qualities.

All candidates must be fluent in English with a working knowledge of French.
