### **Position description**

The Department of Medicine of McGill University invites applications for a full-time position as a member of the Contract Academic Staff as a clinician-teacher or clinician-scientist at the rank of Assistant Professor. This position does not confer eligibility for tenure.

The candidate will also be appointed to clinical practice in the Department of Medicine, Division of Gastroenterology and Hepatology at the McGill University Health Centre (MUHC).

The Department of Medicine is a leader in academic medicine; our educational and research missions support excellent and innovative clinical programs across our teaching hospitals. The McGill University Health Centre is one of McGill's major teaching hospitals affiliated with the Faculty of Medicine and Health Sciences at Canada's internationally renowned McGill University, located in the vibrant and multicultural city of Montreal, in the province of Quebec.

### **Job Duties**

Job duties will include directing the Nutrition Support Service: sharing rounding among five MDs on the MUHC inpatient service and being responsible for the interdisciplinary Home Parenteral Nutrition Clinic. It will include covering the Gastroenterology (GI) Consult Service on rotation, outpatient clinics, and performing endoscopies on in- and outpatients.

The candidate is also expected to be actively involved in all aspects of McGill's academic mission (teaching and supervision of medical students, clinical trainees, and involvement in academic, research and administrative activities) and will be expected to demonstrate a commitment to equity, diversity and inclusion in these activities.

### **Qualifications and Education requirements**

Candidates must hold an MD degree and must have completed subspecialty training in Gastroenterology and certified by the Royal College of Physicians and Surgeons of Canada (or equivalent), as well as be eligible for licensure in Quebec and certified by the Collège des médecins du Québec. Knowledge of nutrition support is required and advanced training in nutrition is an asset. Participating in current research based on the Canadian Parenteral Nutrition Registry, and developing new uses for the database is expected. The candidate must have a strong commitment to patient care, and have clinical and teaching skills. Essential functions required include gastroscopy, colonoscopy, endoscopic management of GI bleeding.

All candidates must be fluent in English and French.
